TO THE HONORABLE FRANCIS W. HARE, JUDGE OF THE TWENTY FIRST JUDICIAL CIRCUIT OF THE STATE OF ALABAMA. SITTING IN EQUITY.

Now comes the Complainant, Vernie S. Gross, humbly complaining of the Defendant, W. W. Gross, in a matter as will here-inafter appear and represents and shows unto your Honor as follows:-

That both the Complainant and the Defendant are over FIRST: the age of twenty-one years and are both bona-fide residents of Baldwin County, Alabama, and have both so resided for more than one year next preceding the filing of this Bill of Complaint. That Complainant and Defendant were married to each other at McCullough, Escambia County, Alabama, on, to-wit, the 28th day of September, 1913, and lived together thereafter as man and wife until, on, to-wit, the 11th day of May, 1942. That for a long time prior to the 11th day of May, THIRD: 1942, the Defendant had commenced to treat the Complainant in a cruel and inhuman manner, and on occasion would threaten, abuse and mistreat her, and that on, to-wit, the 11th day of May. 1942. the Defendant without any just cause or good excuse violently assaulted the Complainant with his fists and broke her nose. That this cruelty was attended with grave danger to her health and life, and that as soon as she could conveniently do so she escaped from the Defendant and has not returned to live with him as his wife nor has she forgiven him for his cruelty in this matter. She

Subdivision of the Town of Bay Minette, Alabama, which said property is worth approximately \$500.00: that the defendant has moneys on deposit in the Baldwin County, Bank, BaymMinette, Alabama amounting to about \$4,000.00; that the defendant has a farm operation of about one hundred acres and that the value of the said farm operation is approximately \$3,000.00.

PRAYER FOR PROCESS

To the end that equity may be had in the premises, the complainant, Vernie S. Gross, prays that the said W. W. Gross be made party defendant to this Bill of Complaint, and that a summons be issued, and together with a copy of the Bill of Complaint filed in this cause, be served upon him, and that he be required to plead, answer or demur to the within Bill of Complaint within the time and under the penalties prescribed by law and the rules of this Honorable Court.

PRAYER FOR IMMEDIATE RELIEF

The premises considered, the complainant, Vernie S.

Gross, humbly prays that Your nonor will immediately cause the Register to hold a reference to ascertain the extent of the holdings, income and property of the said W. W. Gross, and that complainant be granted from the income and property of the said W. W. Gross temporary alimony for her support and maintenance during the pendency of this litigation, taking into consideration the estate and earnings of the defendant, W. W. Gross, and the station in life of the parties.

The complainant also prays that the Registert will determine what will be a reasonable Solicitor's fee to be paid to the solicitors of the complainant for representing her and looking after her interest in this cause; that the Register will hold said reference as speedily as possible, giving the parties and/or their solicitors ten days notice of the time and

place of holding the same, and will report his findings as speedily as possible after the holding of the same.

The complainant further prays that she will be granted her solicitor's fees and other necessary expenses expended in this cause, and that Your Honor will make an order stating the the length of time necessary for the complainant to properly prepare and present her testimony and will order that temporary alimony be paid by the defendant to the complainant during said period of time.

PRAYER FOR FINAL RELIEF.

The premises considered, the complainant prays that upon a final hearing of this cause Your "onor will make and enter a decree granting to the complainant separate maintenance from her husband, the said W. W. Gross, and that in and by virtue of said decree she be given from the estate, earnings and holdings of the defendant in such amounts, and payable at such times as in equity and good conscience she may be entitled to receive.

She further prays that in and by virtue of said final decree her husband, W. W. Gross, be compelled to execute to her a deed conveying to her the homestead which is the home of the parties, in order that she may have a home in which to rear her child.

She prays that in and by virtue of the decree in this cause she be awarded the custody of the minor child, Willie Verne Gross, subject to the further orders of this Court.

The Complainant, Vernie S. Gross, prays such other, further and general relief to which she may be entitled the premises considered and she will ever pray, etc. etc..

the PREMISES CONSIDERED, your petitioner humbly prays that Your Honor will forthwith issue an order to the Register of this Court requiring him to hold a reference to ascertain what will be a reasonable amount to be paid to your petitioner in monthly installments out of the income of the defendant during the pendency of her cause of action against him, taking into consideration the financial condition of

your petitioner, her physical condition, her needs and condition in life; also to ascertain what will be a reasonable fee to be paid by the Defendant, W. W. Gross, to the petitioner's solicitors for representing and looking after her interest in this cause; also the nature, quantity and value of the defendant's property and interest the approximate amount and value of money to be allowed to the petitioner out of the income and estate of her husband and paid into this Court; that the Court will issue an order, Judgment or Decree compelling the Defendant, W. W. Gross, to pay into Court for the remuneration of her solicitors whatever amount is found to be due to said solicitors as a reasonable fee for representing and looking after her interest during the pendency of this cause, as well as alimony pendite litem for such time as the Register ascertains will be necessary for complainant to prosecute her case.
