That the Complainant and the Respondent are both over twenty-one years of age, and residents of Baldwin County, Alabama;

2.

That the Complainant and the Respondent were married at Pensacola, Florida, on September 18, 1938, and lived together as husband and wife in Baldwin County, Alabama, until, togwit: October 1, 1940;

3.

That, on to-wit: October 1, 1940, and at various times prior thereto, the Respondent cursed, threatened and abused the Complainant and did actual violence to her person, which necessarily endangered her life and health; that the conduct of the Respondent was such as to give the Complainant every reasonable apprehension to believe, and she did actually believe that if she continued to live with him as his wife he would do further violence to her person, which would necessarily endanger her life and health;

one son, Willie Joe Goetz, now seven years old; that said child is now and has been all of his life living with the Complainant; that the Respondent is an able-bodied man, easily capable of supporting the Complainant and her minor child; that the Complainant has no funds with which to support herself and child, and with which to prosecute this action;
