One Crop Lien Note and Mortgage for the sum of \$87.08, dated January 21st, 1914, due and payable on November 1st, 1914 and payable to People's Fertilizer Company, or order, and signed by "Joe Wozniak". Witnessed by E. M. Low. Number 4.

One crop Lien Note and Mortgage for the sum of \$73.74 dated February 25th, 1915, due and payable on or before November 1st, 1915 to People's Fertilizer Company, or order, and signed by "Joe Wozniak, Witnessed by C. E. Low, number 599.

One Hundred and Twenty-six Dollars and ten cents (\$126.10) being balance due on said notes above set out.

The Plaintiff alleges that in and by said notes the Defendant agreed to pay a reasonable attorney's fee for collecting or securing the notes if not paid when due and the Plaintiff claims the sum of \$19.00 as such reasonable attorney's fee.

The Plaintiff further alleges that in and by said notes the Defendant waived all his rights as to exemptions under the laws of the State of Alabama and the United States, of this waiver the Plaintiff claims the benefit.
