Answering the interrogatories propounded to the defendants by the plaintiff in the above stated cause, the defendant, Fannie I. Becker, says:-

1. In answer to the first and second interrogatories, the said Fannie I. The defendant, Jerome H. Sheip, Inc., has purchased the said property from the defendant, Fannie I. Becker, subject to the result of plaintiff's claim to the property, and under such purchase is occupying and using some of the property.

2. Answering the third interrogatory, the defendant, Fannie I. Becker, says that according to her information the taxes upon the said property were regularly paid by her deceased husband, Christian Becker, from the time that he acquired the same in 1882; that she believes that the said taxes were regularly paid by her said husband and John A. Cooper during the period that they owned, or claimed to own, the same jointly, which period began in 1870, and continued down to the partition proceeding above mentioned; that ever since the death of her said husband, and beginning with the year 1906, she has paid the taxes on the said property; that it is impossible for her at this time to give the date and amount of each of said payments, but, according to her information and belief, they embraced all taxes upon the said property and were made to the several Tax Collectors of Baldwin County in office at the several times in which the said payments were made.

3. Answering the fourth interrogatory, the defendant, Fannie I. Becker, says that as is hereinabove stated, she is unable to

trace the record title under which she claims back of the year 1850, and cannot connect it up with any patent from the United States.

4. Answering the fifth interrogatory, this defendant says that she and those under whom she claims to have acquired title to the property in question have been in the adverse possession of the said property ever since about the year 1870, and probably long before that time; that the said possession was by Christian Becker and John A. Cooper from the time that they acquired a deed to the property in 1870 up to the partition proceeding between the said Becker and the estate of the said Cooper in 1882; that the said Christian Becker continued to occupy and hold possession of the said property, and to claim the same adversely, up to the time of his death in 1906; that ever since that time this defendant has had adverse possession of the said property claiming it adversely and actually occupying a portion thereof; that throughout the periods of occupancy and possession so mentioned, there has been in cultivation about 80 acres of the said land which has been kept under fence and cultivated each year by, for or under the party or parties then claiming the land as hereinabove stated; that during the most of said periods there has been maintained on the said premises a house for the use of the laborers employed in cultivating the said land; that these cultivated lands consist of the portion of the tract which fronts upon the river, and embrace almost the entire river frontage and extend back several hundred yards; that the remainder of the said land is uncleared and is timbered land; that throughout the said periods of adverse possession hereinabove stated, the respective claimants during the respective periods of their respective claims have protected the same against trespass, exercised such acts of ownership thereover as such land was susceptible of, and occasionally have gotten timber therefrom.

5. Answering the 6th interrogatory, the defendant, Fannie I. Becker, says that her late husband, during his aforesaid possession of the land, caused the same to be surveyed in whole or in part by the late Dan Williams, but that she has not had any survey made.

6. The defendant, Jerome H. Sheip, Inc., answering through its officer having such knowledge of the facts inquired about as is

possessed by said defendant, says that it has no knowledge or information as to any of said matters except its arrangement with its co-defendant set forth in her foregoing answers; that this defendant believes the foregoing answers of its co-defendant to be true; and that it therefore adopts the same.
