The Plaintiff claims of the defendant the sum of Two Hundred Nine and 83/100 (\$209.83) Dollars due from him by promissory note made by him on the 18th day of March, 1915, and payable on the 1st day of November, 1915, with interest thereon from date, which sums of money is still due and unpaid.

The Plaintiff claims of the defendant the sum of Eighty and 00/100 (\$80.00) Dollars due by promissory note made by him on the 21st day of November, 1914, and payable on or before 60 days after date, with interest thereon from date, which sums of money is still due and unpaid.

The Plaintiff further claims of the defendant the sum of ~~Sixty~~ and 00/100 (\$100.00) Dollars as a reasonable attorneys fee for filing this suit as provided in and by said instrument; plaintiff alleges that in and by said instrument defendant waived all right or claim to exemptions allowed him under the constitution and laws of the State of Alabama as to personal property which the plaintiff claims the benefit thereof.
