Sam Ard was, on the 7th day of July, 1930, convicted in the County, of the offense Violation of the Prohibition Law

and by the judgment of said Court sentenced to pay a fine of \$100 and to serve six months of hard labor for Baldwin County

And, whereas, the said Sam Ard has this day prayed an appeal from said judgment to the Circuit Court of said County:

Now, if the said Sam Ard shall appear at the next term of the Circuit Court, and from term to term thereafter until discharged, and abide by and perform whatever sentence may be adjudged in said Court against him, then the above obligation to be void; otherwise to remain in full force and effect.
