The Condition of the above Obligation is such, That, whereas, the above bounden Joe Lee was, on the 6<sup>th</sup> day of July, 1923 /, convicted in the County Court of the offense of Violation of the Prohibition Law

and by the judgment of said Court sentenced to pay a fine of fifty dollars and costs

And, whereas, the said Joe Lee has this day prayed an appeal from said judgment to the Circuit Court of said County:

Now, if the said Joe Lee shall appear at the next term of the Circuit Court, and from term to term thereafter until discharged, and abide by and perform whatever sentence may be adjudged in said Court against him, then the above obligation to be void; otherwise to remain in full force and effect.
