

Peter M. Pedigo being duly sworn testifies as follows:-My name is Peter M. Pedigo, and Iam the Complainant in the case of Peter M. Pedigo vs. Louise M. Pedigo. Louise M. Pedigo, the Respondent, is a bona fide resident of Baldwin County, Alabama, and has been such a resident for more than twelve years before the filing of this Complaint. I, Peter M. Pedigo, am a bona fide resident of Baldwin County, Alabama, residing at Foley, Alabama, and have been such resident for twelve years continuously, next before the filing of the Bill of Complaint in this cause. That on, to-wit, December 23rd, 1929, I was married to Louise M. Brown at Pensacola, Florida. That on or about July 10th, 1931, Louise M. Pedigo, the Respondent, voluntarily abandoned my bed and board without any fault on my part. I was always a good and affectionate husband and she had no cause whatever to leave me. I have repeatedly urged her to return to me, but she always refuses. She said she wouldn't live with me any more Teter Mr. Redig o

Herbert Brice, being duly sworn, deposes as follows:-That his name is Herbert Brice. I live at Foley, Alabama. I know Peter M. Pedigo and Louise M. Pedigo, and have been knowing them about ten or twelve years. I know that both Peter M. Pedigo and Louise M. Pedigo are bona fide residents of Baldwin County, Alabama, and have been such residents for more than ten years next preceding the filing of the Bill of Complaint in this cause. I know that Peter M. Pedigo and Louise M. Pedigo were married on or about December 23rd, 1929. I know that Peter M. Pedigo and Louise M. Pedigo separated in July, 1951. I know that Louise M. Pedigo voluntarily abandoned Peter M. Pedigo. This separation was in no ways caused by Peter M. Pedigo. He was always good and kind to his wife, and I know that Peter M. Pedigo has tried time and again to get his wife, Louise M. Pedigo, to come back to him, but she has refused and continues to refuse to return to him. I know that since the separation in July, 1931, that Peter M. Pedigo and Louise M. Pedigo have not lived together as man and wife. This separation was wholly caused by Louise M. Pedigo.


