This cause coming on to be heard upon the petition of Mrs. Gasque McMillan to remove the disabilities of non-age of Edward Gavin Hall, and upon proof of the allegations of the petition as noted by the Register, and it appearing from the said proof and said allegations that the said Gasque McMillan is the mother of Edward Gavin Hall; that the father of said Edward Gavin Hall is dead; that the said petitioner has been duly appointed and qualified as the guardian of the person and estate of the said Edward Gavin Hall; that the said Edward Gavin Hall is a minor over the age of eighteen years, residing with his said mother in Bay Minette, Baldwin County, Alabama; that he has property in his own right and that the said Edward Gavin Hall is fully matured and of full mental and physical capacity; that he is fully competent to have the care and custody of his properties and that it is to the interest of the said minor that his disabilities of non-age be removed and that he be vested with the right to sue and be sued, contract to buy, sell, and convey real estate and generally to do and perform all acts which such minor could lawfully do if he were twenty-one years of age; and it further appearing that due and proper notice of the said petition has been given in the manner required by law;

It is therefore ORDERED, ADJUDGED AND DECREED that the said minor, Edward Gavin Hall, a minor over the age of eighteen years, be and he is hereby relieved from the disabilities of non-age and is vested with the right to sue and be sued, to contract to buy, sell and convey real estate and to do and perform all acts which said minor could lawfully do on his becoming of the

age of twenty-one years.

It is further ORDERED, ADJUDGED AND DECREED that a copy of this decree be filed and recorded in the office of the Judge of Probate of Baldwin County, Alabama, as required by law.

It is further ORDERED AND DECREED that the petitioner pay the costs of this proceeding.

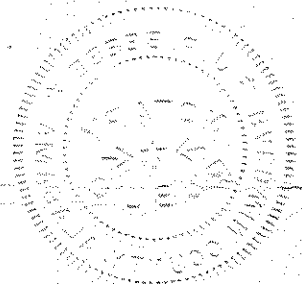

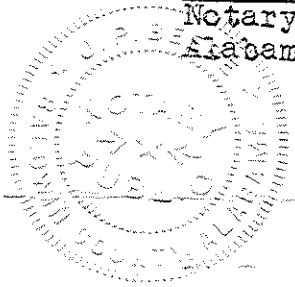

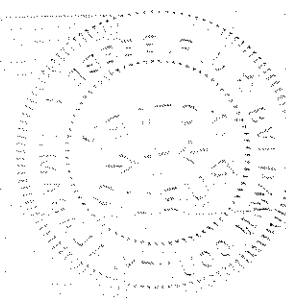
