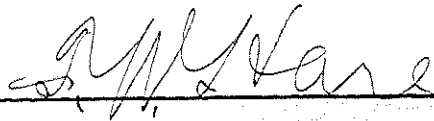
IN THE CIRCUIT COURT OF BALDWIN
