



MOTION FOR MENTAL EXAMINATION


Comes now the Defendant, DENNIS RAY BROWN, by and through his attorney of record, W. KENNETH GIBSON, and moves this Honorable Court to enter an order requiring the Honorable Thomas H. Benton, Sheriff of Baldwin County, Alabama, to deliver the Defendant, DENNIS RAY BROWN, to Searcy Hospital, an Alabama State Mental Hospital in Mount Vernon, Alabama, for the purpose of observation and examination by the medical staff of said hospital, and in support thereof, the Defendant, through his attorney would assign the following, separately and severally, to-wit:

1. The past history of the Defendant reveals that he has a history of mental illness.

2. The Defendant recognizes that he has a mental illness for which he wishes treatment.

3. The Defendant's state of mind and mental capabilities are such that he is unable to adequately assist counsel in the preparation of a defense to the charges lodged against him by the State of Alabama.

WHEREFORE, the premises considered, the Defendant herein, through his attorney, petitions this Court for the <sup>relief</sup> release stated herein above.
