MOTION TO COMMIT DEFENDANT
FOR EVALUATION

Comes now the Mother of the Defendant in the above styled cause, by her attorney, and moves this Honorable Court to enter an order to commit her son, Clifton Bryars, the Defendant, to a mental institution maintained by the State of Alabama for psychiatric examination and evaluation and as grounds therefor says as follows:

1. That the Defendant is now confined in the Baldwin County jail in Bay Minette, Alabama, on a felony charge of grand larceny.

2. That the Defendant is in need of treatment in a mental institution in that his conduct has been such in the past several years so as to indicate that he is suffering from a mental deficiency to the extent that he is not responsible for his actions and conduct and that he may not be capable of properly defending himself of the charge now pending against him.

3. That your Petitioner had her son committed to jail on said charge in that he took her automobile from her possession and control without her knowledge and consent; and your Petitioner is of the opinion that even though her son engaged in such activity, that such conduct was the result of a course of conduct for which he is not responsible because of his present mental condition, and that he is in dire need of evaluation as to such mental condition.

4. That your Petitioner is afraid that if the Defendant were released that he would commit violence on her person for which he would not be responsible in view of his present condition.

WHEREFORE, the undersigned respectfully moves this Honorable Court to order the said Clifton Bryars to be transferred to Searcy Hospital at Mount Vernon, Alabama, for evaluation and psychiatric examination.

ORDERED by the Circuit Court of Baldwin County, Alabama that Clifton Bryars be, and he is hereby ordered to be committed to Searcy Hospital at Mount Vernon, Alabama for evaluation as to his capacity to stand trial for the charge of Grand Larceny, for which charge he is now being held in the Baldwin County Jail at Bay Minette, Alabama.
