FIRST:

He admits the allegations of paragraphs First, Second, Third, and Fourth.

SECOND:

He says that he has refused to pay the said claim because he is informed and believes and upon information and beliefs says that the act of the Legislature of Alabama, namely Local Acts 1931, page 83, et seq under which the said A. P. Pruitt was appointed as Deputy Sheriff and under which he served and under which he bases his claim presenting to this respondent is null and void and of no effect in that:

THIRD

- (a) The same was not passed in accordance with Section 45 of the Constitution of Alabama.
- (b) The said act does not conform to the Constitution of Alabama, namely Section 45.
- (c) The said act embraces two distinct subject matter and both the caption and in the body thereof and, hence, is unconstitutional.
- (d) That the said act in both its caption and the body thereof contains two subject matters, namely the transfer of monies from the Solicitor's Fund to the Fine and Forfeiture Fund and the authorization of the employment of a Deputy Sheriff payable out of such funds.

FOURTH:

And this respondent further answering said petition says that the said act is unconstitutional and void and that there is no other provision in the law under which he could legally pay the said claim; that his refusal to pay the same was lawful; that his payment of same would be illegal and a diversion of public funds to illegal purposes.

TO THE HONORABLE F. W. HARE, JUDGE OF SAID COURT:

Comes your Petitioner, A. P. Pruitt, and shows unto your Honor the following facts as a basis for the relief hereinafter prayed.

FIRST:

That heis a resident citizen of Baldwin County, Alabama, and is over the age of twenty-one years; that J. M. Franklin is a resident citizen of Baldwin County, Alabama, and is the County Treasurer of said County.

SECOND:

That Petitioner was appointed by W. R. Stuart, Sheriff of Baldwin County, Alabama, as a Deputy Sheriff on the first day of January, 1943 at a salary of One Hundred Fifty Dollars (\$150.00) per month, to be paid him by the Treasurer of Baldwin County, Alabama, out of the Fine and Forfeiture fund of Baldwin County, Alabama. Your Petitioner further shows that he has served as such Deputy Sheriff of Baldwin County, Alabama, for the entire month of January, 1943.

THIRD:

Your Petitioner further shows that there is now a surplus in the Fine and Forfeiture Fund of Baldwin County, Alabama, after the payment of all other claims and demands chargable against such fund, sufficient to pay your Petitioner's said claim or demand.

FOURTH:

Your Petitioner further shows that he has presented his claim for said salary which is to be paid out of the Fine and Forfeiture Fund of Baldwin County, Alabama, as conditioned by an Act of the Legislature, which was adopted May 28, 1931, and which

appears in the Local Act of Alabama of 1931 at page 83, to J. M. Franklin as County Treasurer of Baldwin County, Alabama, said claim or demand being in writing and for the sum of One Hundred Fifty Dollars (\$150.00) for payment of his services as such Deputy Sheriff, out of said fund, and that the said J. M. Franklin has failed and refused to pay his said demand or his salary claim.

WHEREFORE, the premises considered, your Petitioner prays that an Order issue out of this Honorable Court commanding the said J. M.
