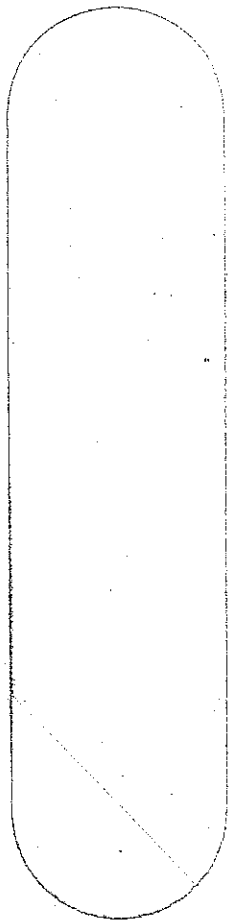

DEFENDANT'S REQUESTED CHARGE NO. 2

The court charge the jury that if the evidence leaves the jury in reasonable doubt as to defendant's guilt, the jury must find the defendant not guilty.

The Court charge the jury that the jury must find the defendant not guilty, unless the evidence against him is such as to exclude to a moral certainty every supposition but that of his guilt.

The court charge the jury that the defendant enters into the trial with a presumption of innocence, which is a fact to be considered as evidence, and should not be disregarded, and the burden is on the state to convince the jury of defendant's guilt to the exclusion of every reasonable doubt, and to exclusion of every other reasonable hypothesis.
