Comes your complainant, Frankie Buck Kelly, in the above styled cause and humbly complaining against R. V. Kelly respectfully shows unto your Honor:

#### FIRST:

Q

That your complainant, Frankie Buck Kelly, is over the age of twenty-one years and a resident of Baldwin County, Alabama, where she has resided all of her life; that the defendant, R. V. Kelly, is over the age of twenty-one years and now a resident of Choctaw County, Alabama.

#### SECOND:

That your complainant and the said defendant are husband and wife, having intermarried at Quitman, Mississippi, January 12, 1950, that they lived together as husband and wife in Bay Minette, Alabama, until April 8, 1950, when they are separated.

#### THIRD:

That the defendant, is a man of violent and ungovernable temper and frequently becomes enraged and when enraged is a dangerous man and often has become enraged at complainant without just cause or reasonable excuse and has cursed and abused complainant and threatened to kill her; That on the evening of April 8th, 1950, he became enraged and threatened and cursed and abused complainant and brutally beat her about the face and body with his fists, causing lacerations and bruises and threatened to kill her; That she separated from him the evening of April 8th, 1950, and they have not lived together as husband and wife since; From his conduct there is probable belief and it is believed that should she continue to live with him he would inflict bodily injury upon her attendant with danger to her life or health.

WHEREFORE, your complainant prays that this Monorable Court will take the jurisdiction of the cause made by this bill of complaint and make the said R. V. Kelly party defendant hereto and by appropriate process require him to plead, answer or demur to the same within the time and under the pains and penalties prescribed by law and the practice of this Honorable Court.

Complainant further prays that upon the final hearing of this cause this Honorable Court will make and enter a decree forever dissolving the bonds of matrimony existing between this complainant and the said defendant, and complainant prays for such other, further or different relief as in equity and good conscience she shall be entitled to receive in the premises.
