FINAL DECREE

This cause coming on to be heard on this date is submitted for final decree on the original Bill of Complaint, Answer and testimony as noted by the Register, upon consideration of all of which, it appears to the Court that the Complainant is entitled to the relief prayed for by her in her said Bill of Complaint, WHEREUPON, it is, therefore, Ordered, Adjudged and Decreed by the Court as follows:

- l. The bonds of matrimony heretofore existing between the Complainant, Mildred Gill, and the Respondent, Robert A. Gill, shall be and they are hereby dissolved and the said Complainant is hereby divorced from the said Respondent on the ground of cruelty.
- 2. The said parties shall not remarry, except to each other, until after the expiration of sixty days from the date of this decree and if an appeal is taken in this cause within sixty days, the said parties shall not remarry, except to each other, until after the termination of the said appeal.
- 3. The costs of this proceeding are hereby taxed against the Complainant, for which execution may issue.
