Harrell, whose Christian name to the Grand Jury is otherwise unknown, did possess, keep, own, set up, operate or conduct, or permit to be set up, operated or conducted, a slot machine, which was a machine, mechanical device, contrivance, appliance or invention for the purpose of winning money by chance or hazard, contrary to law;
