heirs, executors and administrators, jointly and severally. But upon condition, that if the above bound---
Harrold Mikkelsen shall prosecute to effect an appeal by him taking this day to
the next term of the Circuit Court of Baldwin County from a judgment
rendered against him in favor of said State of Alabama
by Jerome Price a justice of the peace for said county, for the
sum of Sixteen - - - - - Dollars, debt
in said appeal, shall pay such judgment, both as to debt and costs as may be rendered against him by the
said Circuit Court then, in either
of said event, this obligation to be void, otherwise to remain in full force and effect.
