are held and firmly bound unto the State of Alabama in the sum of One Hundred Fifty & 00/100 Dollars, for the payment of which, well and truly to be made, we bind ourselves, our heirs, executors, and administrators, jointly and severally, firmly by these presents.

Witness our hands and seals, this the 28 day of Jan, 1939.

THE CONDITION OF THE ABOVE OBLIGATION IS SUCH, That, whereas, the above bounden

Tom Wilson was, on the 28<sup>th</sup> day of Jan 1939, convicted in the Justice County Court of said County, of the offense of Hunting on land of another without a permit to hunt

and by the judgment of said Court sentenced to pay a fine of Ten & 00/100 Dollars and court cost of \$7.00

And, whereas, the said Tom Wilson has this day prayed an appeal from said judgment to the Circuit Court of said County.

Now, if the said Tom Wilson shall appear at the next term of the Circuit Court, and from term to term thereafter until discharged, and abide by and perform whatever sentence may be adjudged in said Court against him, then the above obligation to be void; otherwise to remain in full force and effect; and each of us waive our exemptions as to personal property.
