It is further ordered that the Complainant and Respondent be, and they are hereby permitted to again contract marriage upon the payment of the cost of this suit.

It is further ordered that TRUDIE PEACOCK the Complainant pay the cost herein to be taxed, for which execution may issue.


Comes now your complainant, Trudie Peacock and shows unto your Honor the facts following:

1st. That she is a resident of Baldwin County, Alabama, and has been for more than three years next preceding the filing of this bill, and that she is over the age of twenty one years. That the Respondent, Mike Peacock is over the age of twenty one years and is a non-resident of the State of Alabama, the present address of said respondent is to complainant unknown, and cannot be ascertained after reasonable effort.

2nd. That complainant and respondent were married on to-wit, January 29, 1927 at Gantt, Alabama and lived together as man and wife until to-wit, December 12, 1947. That of such marriage two children were born, Viz. Eleanor Porter and Sue Peacock. Said Sue Peacock now being of the age of seventeen years, and the said Eleanor being now of the age of twenty two years and married to Mr. Porter.

That on December 12, 1947, while complainant and respondent were living together in Fairhope, Baldwin County, Alabama, Respondent voluntarily, and without good cause or legal excuse, abandoned your complainant and since that time has remained away voluntarily and continuously. And complainant avers that said last mentioned date complainant and respondent have not lived together as man and wife.

Premises Considered, your complainant prays that proper process of this court issue to said Respondent, requiring him to plead, answer or demurr to this bill of complaint within the time allowed by law; and upon a final hearing your honor will grant to your complainant a decree of absolute divorce from said Mike Peacock, and that such other relief be granted to complainant as to your honor may seem proper.

The above named appeared before me at the time and place hereinafter stated and upon examination by counsel for complainant, after being sworn, testified, as follows:

SUE PEACOCK

My name is Sue Peacock. I am under the age of 21 years and a daughter of Mrs. Trudie Peacock, who is filing this bill for divorce. I know that my Mother is now a resident of Baldwin County, Alabama, and has been a resident for three years, next preceding the filing of this bill. My Mother is over the age of 21 years and I know that the Respondent, Mike Peacock, is over the age of 21 years and is a non-resident of the State of Alabama. I do not know where Mike Peacock lives. My Mother had two children, Eleanor Peacock Porter and myself.

I further know that on or about December, 1947, my Father, Mike Peacock, abandoned my mother and myself and that there was no reason why he did this. He has remained away since that time. My Mother and Father have been living separate and apart since about 12 December 1947, or ever since they separated.

My name is Trudie Peacock. I am filing this bill for divorce against my husband, Mike Peacock. I am a resident of Baldwin County, Alabama, and live in Fairhope, Alabama. I have been living in Fairhope for over three years next preceding the filing of this bill. I am over the age of twenty-one years and Mike Peacock is, also, over the age of twenty-one years. He has left me and I do not know where he is.

Mr. Peacock is a construction contractor. I tried to locate him by having my daughter write the Mobile Bricklayers Local No. 2, A. F. L., of which he was a member, but could not locate him through that organization. We, also, heard, that Mike Peacock was in Sarasota, Florida, and we inquired of the bricklayer's union there, but could not find his address.

Mike Peacock and I were married on the 29th of January, 1927, at Gantt, Alabama, and lived together as man and wife until he left me in December, 1947. We had two children, namely: Eleanor Peacock, now Mrs. H. D. Porter and Sue Peacock, who is now eighteen years of age.

I know that on or about the 12th day of December, 1947, Mike Peacock abandoned me. I had been a good wife to him and gave him no cause for leaving me. Since that time we have lived separate and apart. Since he left me he has done nothing to contribute to my support or the support of our minor daughter, Sue Peacock. I have not heard from Mike Peacock for over two years.
