POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

That I, Sidney B. Harris, the undersigned, being of legal age, and the one and the same Sidney B. Harris, brother of Addison Nicholas Harris, deceased, late of Donaldsonville, Georgia, do hereby make constitute and appoint, and by these presents have made constituted and appointed Mr. Carl Lovett, my true and lawful attorney in fact, for me and in my name place and stead to receive, receipt for, and to endorse my check in payment thereof, and to take any action as may be found necessary to obtain any undisbursed funds found due me in the Court of Probate in Baldwin County, Alabama, as a result of the sale of lands under the Augustine La Coste grant, and now in the hands of the Judge of Probate of said County, giving and granting unto my said attorney, full power and authority to do and perform all and every act and thing whatsoever necessary to be done, in and about the premises, as fully to all intents and purposes, as I might or could do, if personally present.

I hereby ratify and confirm all that my attorney shall lawfully do, or cause to be done, by virtue hereof.
