Prayer for process: Your Complainant prays Your Honor to grant her all appropriate and legal process and that same be directed to said Kenneth Stewart Rollins demanding him to personally appear before this Honorable Court within the time prescribed by law and to then and there answer fully and completely the several paragraphs of this Bill of Complaint and that he be required to abade and obey all orders and decrees of this Court which to Your Honor may seem meet and proper.

Prayer for Relief: Complainant further prays upon the hearing of this cause that a decree be rendered forever divorcing her from said Kenneth Stewart Rollins, granting her the right to remarry again should she so desire and such further and different relief as may be or appear proper in the premises.
