

TO HONORABLE F. W. HARE, JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, IN EQUITY:

Now comes your complainant, Eflon Maxine Ruffo, and humbly complaining against the Respondent, Attilo Natale Ruffo, respectfully represents and shows unto your Honor and this Honorable Court as follows:

l.

That your Complainant and the Respondent are both over twentyone years of age, and bona residents of Baldwin County, Alabama; that the
Respondent's present address is Atmore, Alabama, Box 38, where he is confined
in the State Convict Camp;

That they were married at Fairhope, in Baldwin County, Alabama, on September 10th, 1941, and that they lived together as husband and wife in Baldwin County, Alabama, until in March. 1942.

That oh, to-wit; in March, 1942, and at various other times prior thereto, the Respondent threatened and abused the Complainant, and often threatened to do violence to her person which would necessarily encanger her life and health; that the conduct of the Respondent was such as to give Complainant every reasonable apprehension to believe, and she did actually believe, that if she continued to live with him he would carry out his threats and do violence to her person which would necessarily endanger her life and health;

That there was born to said marriage between your Complainant and the Respondent one child, Spdney V. Ruffe, now one year old and who is now, and has been all of his life, with Complainant; that the Respondent in addition to the threats committed against the Complainant also committed the offense of grand largeny, for which he was convicted in the Circuit Court of Faldwin County, Alabama, and is now serving time in the penitentiary; that the Respondent is not a suitable, fit or proper person to have the care, custody and control of said minor child, and that your Complainant is a fit, suitable and proper person to care for him.

PRATER FOR PROCESS.

Wherefore, the premises considered, your Complainant prays that your Monor will, by proper process, make the said Attilo Natale Ruffo party Respondent to this Bill of Complaint, requiring him to plead, answer or demur to the same within the time and under the penalties prescribed by law and the practice of this Monorable Court.

Complainant further prays that upon a final hearing hereof your Honor will give and grant unto her an absolute decree of divorce, forever barring the bonds of matrimony existing between her and the Hespondent, that she be awarded the care, custody and control of the minor child, Sidney V. Ruffo, and that your Honor will give and grant unto her such other, further, different and general relief as she may be in equity and good conscience entitled to receive, and as in duty bound she will ever pray.
