COUNT I

The Plaintiff claims of the Defendant THREE HUNDRED EIGHTY ONE and 10/100 DOLLARS (\$381.10), with interest at the rate of 8%, per annum, from January 6, 1965, due by promissory note made by her, onto-wit the 25th day of September, 1963, to Fosberg Furniture Co., Inc. and regular and duly assigned by the Fosberg Furniture Co. to the Plaintiff on to-wit the 25th day of September, 1963, which said note was due and payable in 18 consecutive monthly installments of \$76.22 each, beginning as on the 25th day of October, 1964, which sum of money with the interest thereon is still due and unpaid.

By the terms of said note the Defendant agreed to pay cost of collection or attempting to collect the note including an attorney's fee of 15% and Plaintiff further claims the further and additional sum of 15% of the amount of Judgment as such attorney's
