Rhodes Hospital to be and appear before the Honorable Judge of the Circuit Court for Baldwin County, at the Court House thereof, in the city of Bay Minette, on the _____ Monday in A.D. 30 days from service hereof 19_____, then and there within/~~the three first days of the term~~, to answer on oath, whether at the time of the service of the garnishment, or at the making its answer, or at any time intervening the time of serving the garnishment, and making the answer it was indebted to said defendant and whether it will not be indebted in the future to said defendant by a contract then existing, and whether by a contract then existing it is, or are liable to said defendants for the delivery of personal property,

or for the payment of money which may be discharged by the delivery of personal property, or which is payable in personal property, and whether it has not in its possession or under its control money or effects belonging to the defendant.




