PLEA IN ABATEMENT

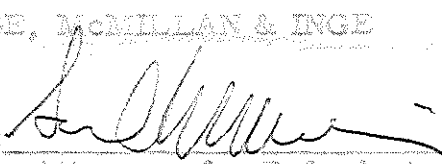

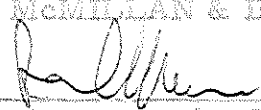

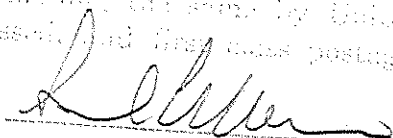

and say:

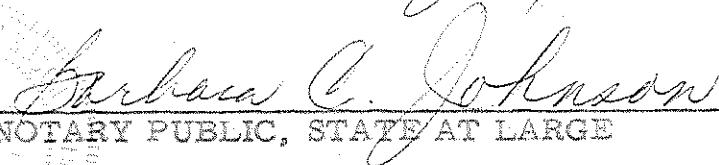
