TO HONORABLE F. W. HARE, JUDGE OF THE CERCUIT COURT OF BALDWIN COUNTY, ALABAMA, IN EQUITY:

Now comes your Complainant, Wilma Ernestine Joiner, and humbly complaining against the Respondent, Lawrence Everett Joiner, respectfully represents and shows unto your honor and this Honorable Court as follows:

1.

That your Complainant is a bona fide resident of Baldwin County, Alabama, eighteen years of age; that your Respondent is a bona fide resident of Baldwin County, Alabama, over the age of twenty one years;

2.

That they were married at Bay Minette, in Baldwin Jounty, Alabama, on August 16th, 1943, and lived together as husband and wife until, to-wit, August 30th, 1943;

That immediately after their marriage, and at various times during their married life, the Respondent cursed and threatened and abused the complainant, and often threatened to do actual violence to her person, which would necessarily endanger her life and health, that the conduct of the Respondent was such as to give the Complainant every reasonable apprehension to believe, and she did actually believe, that if she continued to live with him, he would carry out his threats and do violence to her person which would necessarily endanger her life and health.

PRAYER FOR PROCESS:

Wherefore, the premises considered, your Complainant prays that your Honor will, by proper process, make the said Lawrence Everett Joiner party respondent to this bill of complaint, requiring him to plead, answer or demur to the same within the time and under the penalties prescribed by law and the practice of this Honorable Court.

Complainant further prays that upon a final hearing hereof, your Honor will give end grant unto her an absolute decree of divorce, forever barring the bonds of matrimony existing between her and the Respondent, and that your Honor will give and grant unto her such other, further different and general relief as she may be in equity and good conscience entitled to receive, and as in duty bound she will ever pray.

My name is Wilma Ernestine Joiner. I am eighteen years of age, and a resident of Baldwin County, Alabama. The Respondent, Lawrence Everett Joiner is over twenty one years of age, and a resident of Baldwin County, Alabama.

The Respondent and I were married at Bay Minette, Baldwin County, Alabama, on the 16th day of August, 1943. We lived together only about two weeks, when I found that it was absolutely impossible for us to live together any longer.

The Respondent, immediately after we were married, becan to curse and abuse me, and threatened to do violence to my person which would necessarily endanger my life and health. The Respondent on several occasions did actual violence to my person by striking me. The conduct of the Respondent was such as to give me every reasonable apprehension to believe, and I did actually believe, that if I continued to live with him he would carry out his threats and do fruther violence to my person which would necessarily endanger my life and health.

Neither of us have any property of any kind.

WILLARD JOINER, a witness for the Complainant, being first duly sworn, deposes and says: My name is Willard Joiner. I live at Rabun, in Baldwin County, Alabama. I am personally acquainted with the Complainant and the respondent in the above cause. I remember when they married on August 16th last, and have since that time often been around them.

Immediately after their marriage it was found that they could not get along, and the Respondent on various occasions cursed, threatened and abused the Complainant, and did actual violence to her person which would necessarily endanger her life and health. I know of my own personal knowledge that it is absolutely impossible for the Complainant and Respondent to live together as husband and wife.
