# COMPLAINT

## COUNT ONE

The plaintiff sues to recover possession of the following tract of land situated in Baldwin County, Alabama, to-wit:

From the Northwest corner of the Northeast Quarter of the Northeast Quarter of the Northeast Quarter, Section 30, Township 2 South, Range 3 East, run South 926 feet; run thence North 68° 15' East 700 feet to the right of way of the White House Fork Road; run thence North along said right of way 125.5 feet to the point of beginning; run thence South 79° 31' West 416 feet; run thence in a Northerly direction parallel to the right of way line of said road 205 feet to a point; run thence North 79° 31' East to the right of way line of said White House Fork Road; run thence South along said right of way line 204.5 feet, more or less, to the point or place of beginning, excepting therefrom all oil, gas and other minerals,

to the immediate possession of which the plaintiff is entitled by virtue of the purchase of said land at a sale of same on a foreclosure of a mortgage, and which the defendant, after the termination of his possessory interest, and after the plaintiff's demand in writing therefor, unlawfully detains, together with Two Hundred Fifty Dollars (\$250.00) for the detention thereof.
