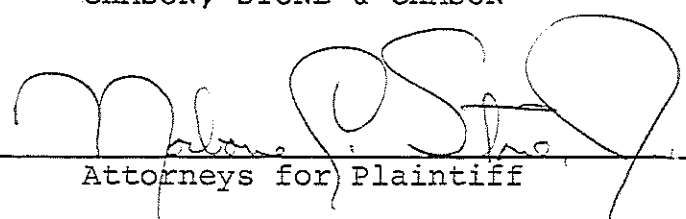
COUNT ONE

COUNT TWO

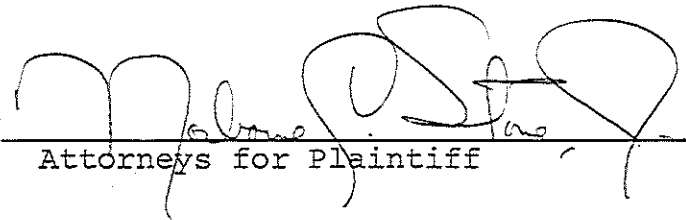
The Plaintiff claims of the Defendant Eight Thousand,
