There is attached hereto a certified verified statement of the account rendered by Plaintiff to the Defendant in this cause.

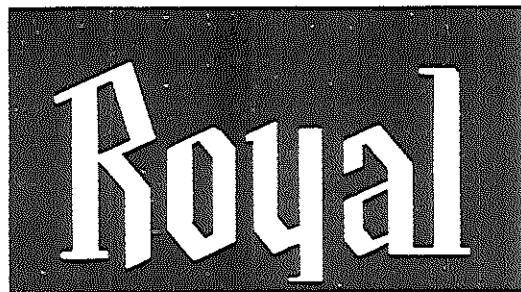
