Comes your Complainant, Annie Mae Brantley and files this her Bill of Complaint for divorce against Charles M. Brantley, and shows unto your Honor and unto this Court, as follows:-

FIRST:

That your Complainant is seventeen years of age and is a resident citizen of Baldwin County, Alabama, residing near Robertsdale; that the Respondent is over the age of twenty-one years and is a resident citizen of Baldwin County, Alabama, residing at Robertsdale, Alabama; that both Complainant and Respondent have lived in Baldwin County for more than ten years last past.

SECOND:

That your Complainant and Respondent were married on heretofore to-wit, December 15, 1942, at Pensacola, Florida, and lived together as man and wife until on account of the matters hereinafter complained of, your Complainant was compelled to leave the Respondent and live separate and apart from him; that on to-wit June 15, 1943, Respondent committed actual violence on the person of your Complainant; that Respondent hit your Complainant in the face two or three times with his fist and choked her; that from his conduct your Complainant had a reasonable apprehension that he would commit further violence on her person attended with danger to her life or health, should she continue to live with him; that your Complainant had the Respondent arrested and placed in jail on the charge of assault and battery and has not lived with him as his wife since that time.

PRAYER FOR PROCESS AND RELIEF.

The premises considered, your Complainant prays that the above named Charles M. Brantley be made a party defendant to this cause by the usual process of this honorable Court, requiring him to appear and plead, answer or demur within the time and under the penalties prescribed by the rules of this Court and the Statutes in such cases made and provided; that upon a final he ring of this cause that your Honor will grant unto your Complainant an absolute divorce from said Respondent and will also decree that your Complainant be allowed to remarry if she sees fit. Should your Complainant be mistaken in the relief prayed for that there be granted unto her such other, further and different relief as she may be entitled, and as in duty bound she will ever pray.

TESTIMONY OF ANNIE MAE BRANTLEY.

My name is annie Mae Brantley. I am the Complainant in that certain cause now pending in the Circuit Court of Baldwin County, Alabama, in Equity, in which Charles M. Brantley is Respondent, said cause being a suit for divorce filed by me against the said Charles M. Brantley. I am seventeen years of age and live near Robertsdale, Alabama, in Baldwin County, and have lived there for more than ten years last past. Charles M. Brantley is over the age of twenty-one years and is a resident citizen of Baldwin County, Alabama, and has resided therein for more than ten years last past. I married Charles M. Brantley on December 15, 1942 at Pensacola, Florida and lived with him as his wife until June 15, 1943, when I was compelled to leave him and live separate and apart from him. On June 15, 1943 Respondent hit me in the face with his fist several times, knocking me down and causing several bruises and cuts aboutmy face. Respondent also choked me and threatened to do further violence to me, and I had reasonable apprehension that if I continued to live with him that he would do further violence to me attended with danger to my life or health. On June 15, 1943 I had the Respondent arrested and placed in jail and charged with assault and battery, and the respondent plead guilty to such charge and paid a fine and the costs in court in Baldwin County, Elabama.

TESTIMONY OF JIM LERCHANT.

My name is Jim Merchant. I am over the age of twenty-one years and a resident citizen of Baldwin County, Alabama, residing at Robertsdale. I am personally acquainted with Annie Mae Brantley and Charles M. Brantley and have known them both for several years. Both Annie Mae Brantley and Charles M. Brantley reside near Robertsdale, Alabama, in Baldwin County, and have resided there for more than ten years last past. I am not related to either of them by blood or marriage. On June 16, 1943 I saw

Annie Mae Brantley and observed the bruises and lacerations about her face and throat. The said Annie Mae Brantley had Charles M. Brantley arrested and placed in jail where he remained for several days. The bruises remained on her face for at least a week or ten days.
