and shows unto your Honor:-


1. That your Complainant is over the age of twenty-one years

plainant has been a resident of Alabama during this entire period.

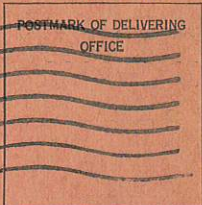
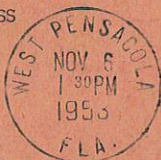
PRAYER FOR PROCESS AND RELIEF

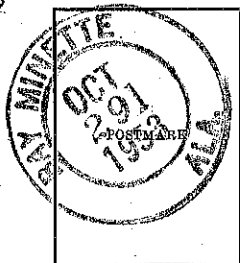
