TO THE HONORABLE F. W. HARE, JUDGE OF SAID COURT:

Comes your Complainant, Frankie Mae Smith, and brings this her bill of complaint against Otis Smith, the respondent, and alleges unto your Honor as follows:

- 1. She is now, and has been for more than one year next preceding the filing of the bill of complaint in this cause, a bona fide resident of Baldwin County, Alabama, and the respondent is also a resident of Baldwin County, Alabama. Complainant is over the age of eighteen years, and respondent is over the age of twenty-one years.
- 2. Complainant and respondent were lawfully married to each other on June 17, 1943, by a Justice of the Peace at Lucedale, Mississippi, and lived together as man and wife until September 4, 1943.
- 3. On said last date of 4, 1943, respondent committed actual violence on the person of complainant attended with danger to her life or health by striking her with his hand and threatening and abusing her, and there being reasonable apprehension of further acts of such violence, complainant for her safety refused to live further with him. Several other acts of such violence had previously occured and the respondent being a man of ungovernable temper complainant feared for her life and health. Complainant and respondent have not lived together as man and wife or otherwise since said last date.

WHEREFORE, the premises considered, complainant prays that proper process issue for service upon the said respondent. Complainant further prays that upon the hearing hereof your Honor and the Court will be pleased to give and grant to her a degree of absolute divorce from the said respondent, with permission to complainant to again marry, if she should see fit so to do. And complainant prays for such other, further and different and decrees as she may be entitled to receive, the premises considered. Complainant further prays that the Court will restore to her her maiden name of Frankie Mae Gilbert.

And Daisy Mae Gilbert, after having been first by me duly sworn, testified, as a witness in behalf of complainant, in substance as follows:

My name is Daisy Mae Gilbert. I am over the age of twenty-one years, am a resident of Bay Minette, Baldwin County, Alabama, and am the mother of the complainant, Frankie Mae Smith. I have read over the testimony of the complainant and know that it is all substantially true. They have not lived together as man and wife or otherwise since September 4, 1943, as she came back to our house to live.

I know that the respondent drank intoxicating liquor to excess and made a habit of that for I have seen him drunk. He ran around a great deal with other men and women and did not treat her in any way as a dutiful husband should. They stayed at my house for about three weeks during August of this year and it was nearly always one or two o'clock in the morning before he would come. He was always very quarrelsome and threatening when he did come. After this they moved to themselves and he continued to mistreat. All of this injured her health to a great extent, and after September 4, 1943, we were afraid for her to go back around him as we apprehended that he would either seriously hurt her or that she would be a nervous wreck.
