TO THE HONORABLE F. W. HARE, JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA, IN CHANCERY SITTING:

#### PART ONE

Your complainant, Julia McCubbin, respectfully shows to Your Honor that she is over the age of 21 years and a bona fide resident of Baldwin County, Alabama, residing in Foley therein and that the respondent James McCubbin is also over the age of 21 years and a resident of Baldwin County, Alabama.

#### PART TWO

- 1. Your complainant further avers that she was lawfully married to the respondent in Bay Minette, Alabama on the 2nd day of November, 1942, has resided in Baldwin County, Alabama ever since said marriage and for many years prior thereto and at all times since said marriage has conducted herself toward the respondent as a faithful and obedient wife.
- 2. That ever since said marriage the respondent has been guilty of extreme cruelty toward your complainant. He is addicted to the use of intoxicating liquor and when under the influence thereof, extremely quarrelsome and violent, when he has many times abused, struck and beat and threatened your complainant and has committed actual violence upon her person so that her health has been affected and she has been able to live with him only about two months since said marriage and finds her married life under such conditions intolerable that she desires a divorce from the respondent.

#### PRAYER FOR PROCESS

Wherefore your complainant prays that Your Honor will grant to her the writ of summons of the State of Alabama, commanding the respondent James McCubbin to appear before this honorable court within the time allowed by law to answer, demur or otherwise plead to this bill of complaint and to abide such order and

decree as may be entered therein; and your complainant shall ever pray, & c.

#### PRAYER FOR RELIEF

Your complainant further prays that upon the final hearing of this cause Your Honor will grant to her a decree of divorce from the respondent James McCubbin and that she may have such other, further and different relief in the premises as may be just and equitable.

#### TESTIMONY OF JULIA MCCUBBIN

My name is Julia McCubbin and I am the complainant in this action for divorce.

I have lived in Foley for a number of years past and was married to the respondent in Bay Minette, Alabama on the 2nd day of November, 1942 and we have both lived in Baldwin County, ever since.

My marriage to the respondent was a mistake. He is a man who drinks considerably and whenever he is under the influence he apparantly finds it impossible to control his temper and the slightest argument or misunderstanding between us would lead to threats, abuse and physical violence on his part to me. Almost from the time we were married, he would push and slap me around and threaten me with violence and he has many times been guilty of actual violence upon my person and threats of even greater violence which made me live in constant fear of him and seriously affected my nerves and health.

We only lived together about four months until I was obliged to leave him and we were separated about two months. Then I yielded to his requests for a reconciliation and his promise to treat me better and went back to him but that only lasted about two months and on last July 10, he struck me again and I left him and we have not lived together since and I am sure that we can never live together happily and will both be better off divorced.

#### TESTIMONY OF JUANITA ABBOT

My name is Juanita Abbot, I live in Foley, Alabama and I have known Julia McCubbin, the complainant in this divorce suit for the past four years and have known her husband since shortly before they were married and ever since.

I lived in the same house with them during the time they lived together and was in their company a good deal of the time and have had many oportunities to observe his treatment of her.

He is a man who drinks and becomes violent when he issunder the influence of liquor.

I have heard their quarrels on numerous occasions when I did not see them and know that he has struck her, committed actual violence on her person numerous times and I have heard him threaten to do her serious injury.

On one occasion when they separated the last time, I saw him strike her.

She left him once and then went back to him upon his promise to do better but his promises were not kept and I know that her health, particularly her nerves were affected by living with him and that she was in fear of injury from him and I am sure they never can live together happily.
