~~IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the custody of Charles Stephen Adams, the minor child of the parties hereto, be and is hereby awarded to the respondent, Renie Melvene Adams, but this shall not relieve the complainant of the legal obligation to maintain and support said child.~~

It is further ordered, adjudged and decreed that neither party to this suit shall again marry except to each other until sixty days after the rendition of this decree, and that if appeal is taken within sixty days, neither party shall again marry except to each other during the pendency of said appeal.

It is further ordered that the Complainant and Respondent be, and they are hereby permitted to again contract marriage upon the payment of the cost of this suit.

It is further ordered that CHARLES LESLIE ADAMS the COMPLAINANT pay the cost herein to be taxed, for which execution may issue.

My name is Charles Leslie Adams. I am complainant in that certain suit for divorce pending in the Circuit Court in equity of Baldwin County, Alabama, against Renie Melvene Adams. I am 24 years of age and she is 23 years old. We are both residents of Baldwin County, Alabama, where we were residing at the time of our marriage and where we have resided continuously since. We were married in Lucedale, Mississippi April 26, 1949. We lived together as husband and wife until April, 1952 when she voluntarily abandoned me without just cause or reasonable excuse and has remained away continuously since. We have one child, Charles Stephen Adams, I have plead with her dozens of times and have written her numerous times asking her to return to me as my wife. She has consistantly and continues to refuse to come. We have agreed between us that custody of Charles Stephen Adams be awarded to her by stipulation attached to my deposition marked Exhibit A.

My name is Alton Grimes. I am a resident of Baldwin County, Alabama, where I have resided continuously for approximately 17 years. I have known Charles Leslie Adams and Renie Melvene Adams for more than ten years continuously. They were married in Lucedale, Mississippi on April 26, 1949 and lived together until April, 1952 when she voluntarily abandoned him. They have not lived together as husband and wife since that date. I am not related to either of them.

Third: That there was born to this complainant and the said defendant one child, Charles Stephen Adams, who is three years of age and in the custody of the defendant.

WHEREFORE your complainant prays that this Honorable Court will take the jurisdiction of the cause made by this bill of complaint and make the said Renie Melvene Adams party defendant hereto and by appropriate process require her to plead, answer or demur to the same within the time and under the pains and penalties prescribed by law and the practice of this Honorable Court.

Complainant further prays that upon the final hearing of this cause this Honorable Court will make and enter a decree forever dissolving the bonds of matrimony existing between this complainant and the said defendant and complainant prays for such other, further or different relief as in equity and good conscience he shall be entitled to receive in the premises.
