This cause coming on to be heard was submitted upon Bill of Complaint, ~~Decree Pro Confesso~~ on Answer and waiver and Testimony as noted by the Register, and upon consideration thereof, the Court is of the opinion that the Complainant is entitled to the relief prayed for in said bill.

It is therefore ordered, adjudged and decreed by the Court that the bonds of matrimony heretofore existing between the Complainant and Defendant be, and the same are hereby, dissolved, and that the said Vivian Juanita Sutton is forever divorced from the said Clement Francis Sutton for and on account of

Voluntary abandonment. IT IS FURTHER ORDERED, ADJUDGED AND DECREED, BY the Court, that the Complainant be and she is hereby awarded the care, custody and control of the two minor children Clement Ronald Sutton and Mary Isabell Sutton, with the right of the respondent to visit at reasonable times. IT IS FURTHER ORDERED, ADJUDGED AND DECREED, by the Court, that the Respondent pay to the Complainant the sum of EIGHTY (\$80.00) DOLLARS per month.

It is further ordered, adjudged and decreed that neither party to this suit shall again marry except to each other until sixty days after the rendition of this decree, and that if appeal is taken within sixty days, neither party shall again marry except to each other during the pendency of said appeal.

It is further ordered that the Complainant and Respondent be, and they are hereby permitted to again contract marriage upon the payment of the cost of this suit.

It is further ordered that Clement Francis Sutton the Respondent pay the cost herein to be taxed, for which execution may issue.

This agreement made and entered into on this the 1st day of March, 1954, by and between Vivian Juanita Sutton, hereinafter referred to as the Party of the First Part and Clement Francis Sutton, hereinafter referred to as the Party of the Second Part, WITNESSETH:

WHEREAS, the Parties heretofore have been husband and wife for a period of six years, and as a result of such union have two children, Clement Ronald Sutton age 5 and Mary Isatell Sutton, age 2; and

WHEREAS said parties have definitely concluded that under conditions now existing it is impractical for them to live together as man and wife.

NOW, THEREFORE, in consideration thereof, and of mutual agreements hereinafter made they have mutually agreed to a complete separation under the following expressed terms and conditions:

1. The said parties shall entirely and completely separate as husband and wife, live separate and apart, as they have been for the past several years, and neither party hereinafter shall in any way harass, threaten, intimidate or otherwise act in anyway so as to embarrass or humiliate the other party.

2. The Party of the First Party shall have the control, custody and support of their two children. The Party of the Second Part shall have the right at reasonable and convenient times to visit the said children and to have the said children to visit him for reasonable periods of time.

3. The Party of the Second Part further agrees to pay the Party of the First Part EIGHTY (\$80.00) DOLLARS per month for the care, support and maintenance of the said children. In addition thereto the Party of the Second Part agrees to pay medical expenses and the premiums on a certain educational policy which is now in effect for the benefit of Clement Ronald Sutton with the Southern Live and Health Insurance Company.

This agreement has been made and executed by the parties hereto on the day and date hereinabove first set forth, in good faith and with full understanding of all of its provisions, and with the mutual promise on the part of each to comply therewith faithfully and completely,

4.




