

The Plaintiff claims of the Defendant the sum of FOUR HUNDRED FORTY FOUR & No/100 (\$444.00) DOLLARS, due by promissory note made by him on the 5th day of January, 1966, and payable in twelve (12) monthly installments, each in the sum of THIRTY SEVEN (\$37.00) DOLLARS, beginning with February 7th, 1966, and a like amount on the same date of each succeeding month thereafter, which said note provides in the event of default in the payment of any installment of principal or interest, the Plaintiff shall have the right at its election and without notice to the Defendant to declare the entire indebtedness evidenced by said note immediately due and payable, which said note is still unpaid.

The Defendant by said note waived as to this debt all rights of exemption under the constitution and laws of the State of Alabama, or any other state, and the Plaintiff claims the benefit of said waiver.

Plaintiff further avers that as a part of the consideration

for said note, and which said note provides, that the Defendant would pay all costs of collecting said note, including a reasonable attorney's fee, and the Plaintiff claims the further and additional sum of SEVENTY FIVE (\$75.00) DOLLARS, as a reasonable attorney's fee in the premises.
