

Count I.

The Plaintiff claims of the Defendant the sum of TWO HUNDRED THIRTY TWO AND 13/100 (\$232.13) DOLLARS due by promissory note made by Defendant on the 23rd day of May, 1966, and payable in twelve monthly installments of TWENTY AND NO/100 (\$20.00) DOLLARS each, the first installment due June 23, 1966, and the final installment due May 23, 1967, and this note provides that the failure to pay any installment shall entitle the holder to declare whatever total balance remains unpaid due and payable without notice and the Defendant defaulted on the first payment on this note, which sum of money with the interest thereon is still unpaid.
