Edmandson is emtitled to the relief prayed.

It is therefore ORDERED, ADJUDGED and DECREED that the Defendant Helen I. Stewart has no estate or interest in or encumbrances on the following described land or any part thereof, namely:

IN EQUITY:

Comes ELEANOR J. EDMUNDSON and by this her Bill of Complaint presented against HELEN I. STEWART, respectfully shows:

FIRST: That Complainant is a resident of Fairhope, Baldwin County, Alabama, and over the age of twenty-one years; that the Defendant, HELEN I. STEWART, is over the age of twenty-one years and is a non-resident of the State of Alabama, living at South Bend, Indiana.

SECOND: That Complainant is the owner of and in actual physical possession and occupancy of lots 3 and 4 and the east thirty-five feet of Lot 2 in Block 7 of Ingleside Highlands, a sub-division of the Town of Fairhope, Baldwin County, Alabama, and a plat of which sub-division is on record in the Probate Court of Baldwin County.

THIRD: That Defendant, HELEN I. STEWART, is reputed to claim some right, title or interest to or claim in the property above described.

FOURTH: That no suit is pending affecting or tending to determine the claim of any party to said lands.

THE PREMISES CONSIDERED, Complainant prays that HELEN I. STEWART be made party Defendant to this Bill and being a non-resident be given notice by registered mail, requiring her to plead, answer or demur to the Bill of Complaint within the time prescribed by law and abide by such orders or decrees as may be made in the premises.

Complainant further prays that upon hearing of this cause a decree be rendered declaring that the said HELEN I. STEWART has no claim, right or interest in the above described property and forever quieting all claim or demand on her part against the same. Complainant further prays for such other, further or different relief as to equity may seem meet.
