#### COMPLAINT

The plaintiff claims of the defendant TEN THOUSAND DOLLARS (\$10,000.00) due by a promissory note made by Springhill Broadcasting Company, Inc., a Louisiana corporation, dated April 27, 1964, and payable to the plaintiff in two (2) annual principal installments of \$5,000.00 each, the first of which became due and payable on, to-wit, April 27, 1965, and the second became due and payable on, to-wit, April 27, 1966, which sums of money, together with the interest thereon from date, are still due and unpaid.

The defendant endorsed and guaranteed said note in the

following language: "I, the undersigned, hereby personally endorse and guarantee this note and all indebtedness evidenced thereby.

/S/ SAMUEL R. DAVID."

In and by the terms and provisions of the said note, the maker and endorser waived demand, protest and notice of protest, waived all rights of exemption under the Constitution and laws of Alabama, and all requirements necessary to hold them liable as makers and endorsers, and further agreed to pay all costs of collection, including a reasonable attorney's fee. The plaintiff alleges that a reasonable attorney's fee for the collection of the said note is the sum of Two Thousand Dollars (\$2,000.00), which it also herewith claims.
