TESTIMONY OF ESTHER H. HEDDEN.

My name is Esther H. Hedden; I am the Complainant in the suit for divorce filed against Roy Lee Medden on February 15, 1944 in the Circuit Court of Baldwin County, Alabama, In Equity; both Roy Lee Hedden and I are over the age of twenty-one years and are resident citizens of Robertsdale in Baldwin County, Alabama, and we have both lived in Robertsdale for more than six years last past; I married Roy Lee Hedden on July 10, 1939 and I lived with him as his wife until February 12, 1944 when I was compelled to leave him and live separate and apart from him. The Respondent has committed actual violence on my person attended with danget to my life or health on two or three occasions before the time when I left him. A little over two years ago he beat me to such an extent that several of my ribs were dislocated and there was a serious injury to my back. I was also injured on my knee so that the scar still remains. At this time I was required medical treatment and have never completely recovered from the injuries I received. On the night of February 12, the Respondent hit me on the top of the head with his fist and hit me on the back of the right shoulder. The licks caused a large knot to come on the top of my head and severely injured my shoulder. I have had a great deal of pain and suffering from both the injuries on my head and on my shoulder. He hit me with his fist about five times on the night of February 12, 1944. He has made threats against me and I have every reasonable apprehension that my life or health will be in danger if I continue to live with him.

On the night of February 12, 1944 after he hit me several times I dressed and went to the home of my mother, Mrs.

Clara Dawkins near Robertsdale. I showed her the bruises on my head and shoulder and I have been living with her since that time.

TESTIMONY OF MRS. CLARA DAWKINS.

My name is Mrs. Clara Dawkins; I am over the age of twenty-one years and am a resident citizen of Robertsdale, Alabama; I have lived there several years; I am the mother of Esther H. Hedden, who married Roy Lee Hedden on July 10, 1939, and I have known Roy Lee Hedden for many years. Both my daughter Esther H. Hedden and Roy Lee Hedden are over the age of twenty-one years and residents of Robertsdale, Alabama, in Baldwin County, and they have both resided in Robertsdale, in Baldwin County, Alabama, for more than six years immediately preceding the filing of the Bill of Complaint in the suit for divorce that my daughter brought against him. Roy Lee Hedden has committed actual violence on the person of my daughter Esther on two or three occasions before the night that she left him. A little over two years ago he beat her so that it was necessary that she have medical treatment. At that time he dislocated some of her ribs and injured one of her legs and also caused some injury to her back. She has been treated by both Dr. Jordon and Dr. Hale in connection with these injuries.

On the night of February 12, 1944 about midnight my daughter Esther H. Hedden came to my home near Robertsdale and showed me the bruises and knots that she said Roy Lee Hedden had made on her. I examined the knot on the top of her head and I examined the bruises on her shoulder. She appeared to be in great pain and the knot and bruises are still on her. She has continued to live with me since that time and she has not lived with Roy Lee Hedden as his wife since the night of February 12, 1944.
