Beginning on 1st April, 1967, and on the same day of each month thereafter, there shall be due and payable the sum of FORTY ONE DOLLARS AND SIX CENTS (\$41.06), until the total indebtedness has been paid in full.

There shall be no interest payable on these payments.

Each maker and endorser waives the right of exemption under the Constitution and laws of Alabama and each maker and endorser waives demand, protest and notice of protest and all requirements necessary to hold them liable as makers and endorsers.

It is further agreed that the undersigned shall pay all cost of collection, including a reasonable attorney's fee on failure to pay any installment of principal and interest of this note on the date due hereof.

Upon failure to pay any installment of principal and/or interest when due or if any of the conditions and requirements be not complied with, the entire principal sum, at the option of the holder, shall become due and payable. Failure to exercise this option shall not constitute a waiver of the right to exercise the same in the event of any subsequent default.
