



Plaintiff claims of the defendants, Bernarda J. Contreras and Reynaldo Bill Arreal, the sum of Five Hundred (\$500.00) Dollars as damages, for that heretofore on to-wit, April 30, 1967, about 4:30 P.M. said plaintiff was operating an automobile on a public highway in Baldwin County, to-wit: U. S. Highway numbered 98; Alabama Highway numbered 42 at a point approximately 9 miles from the City of Fairhope between Fairhope and Foley, where he had a right to be and defendant, Bernarda J. Contreras, agent, servant or employee of Reynaldo Bill Arreal, a passenger in said automobile, so negligently operated said motor vehicle which she was then and there operating so as to run into, upon, over or against the automobile which your said plaintiff was then and there operating and your said plaintiff avers that as a proximate consequence thereof, his said automobile was damaged on the right side damaging right front headlight, the front fender, both doors on the right side, and the rear fender, all of which damages were proximately caused by the said negligence of said defendant in the negligent operation of said motor vehicle at the time and place and on the occasion as aforesaid.


