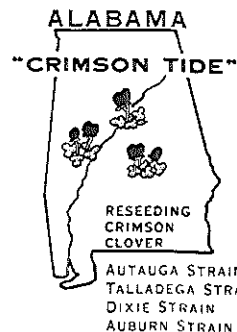



WHEREAS, James R. Owen has made affidavit as required by law that on October 9, 1967, in the Circuit Court of Baldwin County, Alabama, the plaintiff, Baldwin County Savings and Loan Association recovered a judgment against the defendant, Robert A. Grimes, for the sum of Five Hundred Eighty and 44/100 Dollars (\$580.44) and for the further ~~sum of \$~~ cost of suit; and that he believes the process of garnishment is necessary to obtain satisfaction of said judgment; and that Sta-Green Food Company has, or is believed to have in its possession or under its control, money or effects belonging to the defendant or that Sta-Green Food Company is believed to be indebted to the defendant or to be liable to him on a contract for the delivery of personal property, or on a contract for the payment of money which may be discharged by the delivery of personal property, or which is payable in personal property.
