Plaintiff claims of the Defendant the sum of TWO-THOUSAND SEVEN-HUNDRED TWO and NO/100 (\$2,702.00) DOLLARS, as balance due by promissory waive note for \$3,084.00 made by him on December 11, 1964 and payable on the 1st day of January, 1967 with interest thereon.

The note contains provision for a reasonable attorney's fee and waiver of exemption whereof Plaintiff claims benefit.

II

Plaintiff claims of the Defendant the sum of EIGHT-HUNDRED SIXTY-THREE and THIRTY/100 (\$863.30) DOLLARS, as balance due by promissory waive note for \$1,192.00 made by him on November 5, 1962 and payable on the 5th day of August 1963 with interest thereon.

The note contains provision for a reasonable attorney's fee and waiver of exemption whereof Plaintiff claims benefit.
