
The Plaintiff claims of the Defendant the sum of THREE HUNDRED FORTY AND 34/100 (\$ 340.34) DOLLARS, due by a promissory note made by him on the 27th day of July, 1966, and payable in twelve (12) monthly installments of THIRTY-SIX AND 40/100 DOLLARS each, which said Defendant is now delinquent in his payments of the aforesaid amount from the 25th day of January, 1967. That said note provides for a reasonable attorneys fee to be paid if collection is necessary by an attorney. Plaintiff further avers that the sum of THREE HUNDRED FORTY AND 34/100 (\$340.34) DOLLARS is now due and unpaid from the 25th day of January, 1967, plus interest thereon at the rate of six per cent (6%) per annum from that date and a reasonable attorneys fee in the amount of SOXTY (\$60.00) DOLLARS.
