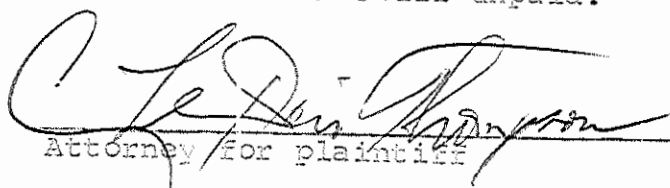
Whereas, said note in the balance due amount of Three Hundred Twenty-four (\$324.00) Dollars with interest thereon is still unpaid.
