Abandonment. IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Court
that the Complainant be and she is hereby awarded the care, custody and
control of the said minor child, Donald Butler.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Court that the
Complainant, Rennie Pearl Butler, be given and she is hereby granted the
sum of Seven (\$7.00) Dollars per week until September 1, 1951, and that
this sum be increased to \$8.50 per week, each week, thereafter, for
maintenance and support for said child.

It is further ordered, adjudged and decreed that neither party to this suit shall again marry except
to each other until sixty days after the rendition of this decree, and that if appeal is taken within sixty
days, neither party shall again marry except to each other during the pendency of said appeal.

It is further ordered that the Complainant and Respondent be, and they are hereby permitted to
again contract marriage upon the payment of the cost of this suit.

It is further ordered that Joseph Wilson Butler
the Respondent pay the cost herein to be taxed, for which execution may issue.



The Respondent admits the allegations as to ages, marriage and residence, but denies all other allegations contained in the bill of complaint, and demand strict proof of the same.



That my name is Rennie Pearl Butler, and my husband is Joseph Wilson Butler. We are both over the age of 21 years and citizens of Baldwin County, Alabama and have been more than two years next preceding.

We were married September 27, 1942 at Pascagoula, Miss., and lived as husband and wife until May 16, 1949, at which time we separated, and he had me brought home to my people. We have not lived together as husband and wife since that day. The separation was through no fault of mine.


