The following testimony was taken in open Court before Honorable Telfair J. Mashburn, Jr., Judge of the Circuit Court of Baldwin County, Alabama, Sitting in Equity, on September 26, 1951.

#### STIPULATION

IT IS AGREED between the respective parties to this cause that Sicilia C. Brueggemann, Complainant, is the proper person to have the care, custody and control of the minor children of the parties, Edward Charles Brueggemann and Frederick Anthony Brueggemann, at the present time.

IT IS FURTHER AGREED between the parties that the Respondent, Edward S.Brueggemann, is now earning Fifty Dollars (\$50.00) a week, but that after deductions for income and social security taxes, his take-home pay amounts to between Forty-two and Forty-five (\$42.00 and \$45.00) Dollars per week.

Mrs. Helen G. Posey, having been first duly and legally sworn, testified as follows:

ON DIRECT EXAMINATION

By Mr. Chason

Q. What is your name?

A. Helen G. Posey.

- Q. Posey?
- A. Yes sir.
- Q. Are you a sister of Sicilia C. Brueggemann?
- A. Yes sir.
- Q. Where do you live, Mrs. Posey?
- A. On Moffatt Road, Crichton Station, Mobile, Alabama.
- Q. Do you know Edward S. Bruggemann?
- A. Yes sir.
- Q. How long have you known him?
- A. Since 1946.
- Q. Did you see your sister, Mrs. Brueggemann, soon after she returned from St. Louis last March 14, 1950?
- A. Yes sir.
- Q. Do you know how many days it was after she returned before you saw her?
- A. The next day.
- Q. At that time, when you saw her, did you observe any bruises on her body?
- A. Yes sir.
- Q. What bruises did you see?
- A. There was a cut over her right eyebrow.
- Q. Cut over her right eyebrow?
- A. Scuff marks on her ear, plummeted marks, likely by punching, her left ankle was swollen and her ear was pulled.
- Q. You mean sort of torn?
- A. Yes sir.
- Q. Where did you see your sister at that time?
- A. At the home of my parents and her parents.
- Q. In Baldwin County?
- A. Daphne, Alabama, yes sir.
- Q. Now, you have been knowing Mr. Brueggemann ever since before the marriage of your sister to Mr. Brueggeman on January 12, 1948, have you not?
- A. Yes sir, that is correct.
- Q. I will ask you if on one occasion some two weeks after her marriage you were called to Mrs. Snow's in Mobile to come and get your sister and keep her for the night?

- A. Yes sir.
- Q. About how long after their marriage did that occur?
- A. Two weeks.
- Q. About what time of night did you go get Mrs. Brueggemann?
- A. Approximately ten o'clock.
- Q. What was her condition that night?
- A. That night she was nervously torn up, had been sent out of the house, thrown out.
- Q. About being sent out, were you going by what she told you?
- A. Yes sir.
- Q. You didn't see her?
- A. No, I didn't live there.
- Q. Did you keep her that night?
- A. Yes sir.
- Q. Did you and your husband take her home the next morning, back to her apartment?
- A. We took her home about nine o'clock, went with her to the apartment.
- Q. Was Mr. Brueggemann at home?
- A. Yes sir.
- Q. What was he doing?
- A. Drinking coffee.
- Q. About what time in the morning was that?
- A. About nine or nine-thirty.
- Q. Was anything mentioned between you all about the disturbance the night before?
- A. Oh, no sir.
- Q. You left your sister there with him?
- A. After staying long enough to see, to feel that -
- Q. Everything was all right?
- A. Yes sir.
- Q. Did your sister leave Mr. Brueggemann on any more occasions that you know of?

- A. Yes sir, two weeks later I was called to her place where she worked?
- Q. What place was that?
- A. It was the Marine Hospital. It is operated by the United States Public Health Service now.
- Q. What did you find when you got there?
- A. She was scratched, black and blue marks on her body.
- Q. Soon after that did she and Mr. Brueggemann move to St.Louis, Missouri?
- A. She stayed with me a whole week. On that second occasion.
- Q. On that second occasion? Was she separated from Mr. Brueggemann during that week?
- A. Yes sir, he was out of town on business and she was in my home.
- Q. After that did they move to St. Louis?
- A. Yes sir.
- Q. While she was living with him in St. Louis did she leave and come home on any occasion?
- A. On four occasions.
- Q. On four occasions? While they lived in St. Louis?
- A. Yes sir.

Mrs. Daisy Snow, having been first duly and legally sworn, testified as follows:

# ON DIRECT EXAMINATION

By Mr. Chason

- Q. Is this Mrs. Daisy Snow?
- A. Yes sir.
- Q. Where do you live, Mrs. Snow?
- A. At 25 Hulbert Street, Mobile.
- Q. On Hulbert Street? Do you know Sicilia Brueggeman and Edward S. Brueggeman?
- A. Yes sir.
- Q. Abouthow many years have you known them?
- A. Since 1946.

- Q. Are you related to either one of them in any way?
- A. No sir.
- Q. Mrs. Snow, along about the first of February, 1948, did Mrs. Brueggeman come to your house one night soon after her marriage?
- A. I had to go get her.
- Q. You went to get her, where did you go for her?
- A. I picked her up at the Dew-Drop Inn, Shell Road, Mobile.
- Q. At the Dew-Drop Inn on Shell Road? Was that near the apartment where she had been living?
- A. Mes sir.
- Q. Why did you pick her up?
- A. She called me to come get her.
- Q. Do you know about what time of night you went to pick her up?
- A. I should say about 9:30.
- Q. Where did you carry her?
- A. I took her to my house.
- Q. Did you notify any person for her that she was at your house?
- A. Yes sir, I called her sister to come after her.
- Q. Her sister; is that Mrs. Posey?
- A. Yes sir.
- Q. Now, did you notice her condition at the time you picked her up at Dew-Drop Inn?
- A. She was rather up-set and a little bit on the hysterical side.
- Q. Did she remain in that condition as long as you were with her that night?
- A. Yes sir.
- Q. Now, did you know of any separations that she had with her husband before she went to St. Louis to live?
- A. She went home for about, I guess a week, maybe, before she went to St. Louis.
- Q. Did you see her on that occasion when she was separated from Mr. Brueggemann?
- A. Only at work.
- Q. Did you observe any bruises on those occasions?
- A. No sir.

- Q. Now, I will ask you if you saw her when she returned home about March, of last year, from St. Louis?
- A. Yes.
- Q. How long after she came back from St. Louid did you see her?
- A. The following afternoon.
- Q. The following afternoon?
- A. Yes sir.
- Q. Did you observe any bruises on her body the next afternoon?
- A. Yes sir.
- Q. Just tell the Court what you saw.
- A. She had a cut across her right eye, her left ankle was swollen, she had bruise marks on her arm, she was all black and blue, and both knees were skinned.
- Q. You say you are not related to her, to either one of them in any way?
- A. No sir.

Mrs. Mary Guarisco, having been first duly and legally sworn, testified as follows:

#### ON DIRECT EXAMINATION

- By Mr. Chason
- Q. Is this Mrs. Mary Guarisco?
- A. Yes sir.
- Q. Where do you live, Mrs. Guarisco?
- A. In Daphne.
  - Q. Is Sicilia C. Brueggemann your daughter?
  - A. Yes sir.
  - Q. Is she living there in your home with you know?
  - A. Yes sir.
  - Q. Are her two children living there with you?
- A Yes sir.
- Q. Has she been living there in that home since March of last year?
- A. Yes sir.

- Q. I will ask you, Mrs. Guarisco, whether you saw her the night or the next day after she returned from St. Louis in March of last year?
- A. Yes sir, we saw her the same day.
- Q. Did you observe any bruises on her body?
- A. Yes sir.
- Q. What did you observe?
- A. I observed her ear, it was very bruised, and her eyes, she had bruises on her knees and different parts of her body.
- Q. Has she lived with Mr. Brueggemann as his wife since that time?
- A. No sir.
- Q. That was March, 1950?
- A. Yes sir.

Mrs. Sicilia C. Brueggemann, having been first duly and legally sworn, testified as follows:

#### ON DIRECT EXAMINATION

By Mr. Chason

- Q. Is this Sicilia C. Brueggemann?
- A. Yes sir.
- Q. You are the wife of Edward S. Brueggemann?
- A. Yes sir.
- Q. Are you and Edward S. Brueggemann both over twenty-one years of age?
- A. Yes sir.
- Q. Do you both live in Baldwin County, Alabama?
- A. Yes sir.
- Q. Do you reside at Daphne?
- A. Yes sir.
- Q. Have you been a resident citizen of Baldwin County all your life except for about two years when you lived with your husband at St. Louis?
- A. Yes sir.

- Q. Have you been a resident citizen of Baldwin County since you returned in March of 1950?
- A. Yes sir, I have.
- Q. When did you and Edward S. Brueggemann get married?
- A. January 12, 1948.
- Q. Now, about two weeks after your marriage on January 12, 1948, did you have a disturbance?
- A. Yes sir, I did.
- Q. Where were you living at that time?
- A. Silverwood, in Mobile.
- Q. Tell the Court what happened on that occasion.
- A. I had come back from work. My husband was home at that time and we were finishing the evening meal. I don't know what caused it, but he got all excited about something and started accusing me of doing all kind of things that I never thought of doing and he struck me, got me down on the floor and was beating my head on the floor and then he picked me up bodily and threw me out the door in my nightgown. I asked if I might come in and put my clothes back on and then I would leave, which I did so. We didn't have a phone in the house so I walked around to the Dew Drop and called Mrs. Snow to please come get me.
- Q. Did Mrs. Snow come around and pick you up there?
- A. Yes sir, she did.
- Q. That's the lady who testified a few minutes ago?
- A. Yes.
- Q. Then, did she phone your sister, Mrs. Posey, to come get you?
- A. Yes sir.
- Q. Did Mrs. Posey take you home with her that night?
- A. Yes sir.
- Q. Then did she take you back to your apartment the next day like you testified about?
- A. Yes sir.
- Q. I will ask you whether about two weeks after that occasion that you had another incident with your husband?
- A. Yes sir.
- Q. What happened on that occasion?

- A. The same as happened the time before. He beat me brutally and slapped me all over the place and he would hit me and he would push me around but I didn't leave that night. He finally calmed down and we went on to bed but I had to get up and go to work the next day and just as soon as I got to work I called my sister to come down there.
- Q. Now, where did you work at that time?
- A. At the Marine Hospital in the laboratory.
- Q. Where are you working at this time?
- A. With Dr. Hayes and John Ziemann.
- Q. Did you stay with your sister about a week on that second occasion?
- A. Yes sir, I did.
- Q. Now after that, shortly after that, did you and your husband move to St. Louis, Missouri?
- A. Yes sir.
- Q. Did you leave him on more than one occasion while you were in St. Louis?
- A. Yes sir, I did, at four different times.
- Q. Were those occasions, without going into detail, caused by similar acts to those you just referred to?
- A. Yes sir, he would get very violent and it was during my pregnancy that he didn't abstain from beating me even then.
- Q. Now, you have two children?
- A. Yes sir.
- Q. One child who is now almost three years of age?
- A. Yes sir.
- Q. Now at the time of your last separation you had just gotten pregnant with your last child, had you not?
- A. That is true.
- Q. About how far along were you in your last pregnancy, that is, your pregnancy with the second child when the last act of cruelty occurred?
- A. I would say I was six weeks to two months.
- Q. Tis happened in March and the baby was born about October, was it not, of last year?
- A. Yes sir.

- Q. Now, on that occasion while you were pregnant what did he do to you?
- He had been out hunting a job. He had quit his job where he was employed at the bank and I don't know whether he was discouraged about that I don't know. I had prepared an evening meal and he came in, I would say he had been drinking, and he slammedbreaking up the dishes that were on the table and I was frightened for the child and I tried to intervene and tell him to calm down, then he started beating me and he did that night, he got me against the wall pounding me with his fist and hit my ear, I got slammed against a corner and cut my eye and then when I finally got to my baby who he was screaming at the time, it's bound to have upset him, he caught and shoved me away and threw me against the sofa then he grabbed me by the leg and drug me all over the living room at that time and when he finally released me I grabbed the baby and as best I could got out and went down stairs to a neighbor until he calmed down, then I went upstairs and the first thing the next morning I called the movers and they moved me out.
- Q. Have you lived with him as his wife since that time?
- .A. No sir.
- Q. Was that on about March 14, 1950?
- A. Yes sir.
- Q. Did you return home to Baldwin County immediately after that?
- A. Yes sir.
- Q. Did your sister, Mrs. Posey and Mrs. Snow, and your mother, Mrs. Guarisco, see your bruises that you told about?
- A. Yes. They were very obvious.
- Q. Where have you lived since that time?
- A. With my mother.
- Q. Did your mother help, and the rest of your family help you to take care of the children while you work?
- A. When I was unemployed they helped me financially raise them.

- Q. Who paid for the birth of your last baby, the last doctor bill?
- A. My sister did. She paid for the hospital bill and I in turn now am paying her back for the babies and their support.
- Q. Is Edward Charles Brueggemann, was he about two and one-half years old at the time of the filing of this bill?
- A. Yes sir, he was.
- Q. And was Frederick Anthony Brueggemann about eight months old at the time you filed your bill?
- A. Yes sir.
- Q. You do have their custody at this time, do you not?
- A. Yes, I do.
- Q. And they live with you in your mother's home in Daphne?
- A. Yes sir.
- Q. Did you employ solicitors to represent you in this case; attorneys?
- A. Yes sir.
- Q. In other words did you employ Chason and Stone as your solicitors?
- A. Yes sir.
- Q. Have you paid them anything or been able to pay them anything for their legal services?
- A. No sir.

Brueggemann, was ordered to pay the sum of \$12.00 per week, commencing October 1, 1951 and each Monday thereafter, for the support and maintenance of Edward Charles Brueggemann and Frederick Anthony Brueggemann, children of this marriage.
