At a regular term of the Circuit Court in Equity for the County of Baldwin, State of Alabama, and held in Bay Minette, Alabama, on the 29 day of March, 1954, it was ORDERED, ADJUDGED AND DECREED as follows:

In the matter of the Petition of LILLIE BELL PRICE MALONE in the Circuit Court of Baldwin County, Alabama, in Equity No.

#3224.

This is a Petition filed by LILLIE BELL PRICE MALONE, the mother of BARBARA FAYE PRICE, a minor, above the age of eighteen (18) years and on behalf of the said BARBARA FAYE PRICE. It is made to appear to the Court by the Petition and evidence, that the father of the said BARBARA FAYE PRICE is dead and that said Petition is properly brought by the said LILLIE BELL PRICE MALONE, the Court has examined the pleadings and evidence offered in behalf of said minor, and being satisfied that said minor is of sufficient intelligence to be entrusted with the management of her Estate, and that it would be to her best interests to grant the prayer of the Petition.

It is therefore ORDERED, ADJUDGED AND DECREED that the said BARBARA FAYE PRICE, a minor over the age of eighteen (18) years, be and she hereby is relieved from the disabilities of non-age, and is now invested with the right to contract, sue and be sued, to buy, sell, and convey real estate, and to do and perform all acts which this said minor could lawfully do on her becoming the age of twenty-one (21) years.

TO THE HONORABLE JUDGE OF SAID COURT, SITTING IN EQUITY:

Your Petitioner, the undersigned LILLIE BELL PRICE MALONE, respectfully represents and shows unto Your Honor as follows:

1. That she is over the age of twenty-one (21) years and is a resident of the City of Fairhope in the County of Baldwin, State of Alabama.

2. That she is the mother of BARBARA FAYE PRICE, a minor over the age of twenty (20) years; that the father of the said minor, BARBARA FAYE PRICE, is dead, and that the said minor has no legal guardian; and that said minor and Petitioner are both residents of this said County and State; although said minor is presently temporarily enrolled in the Alabama Polytechnic Institute at Auburn, Alabama.

3. That the said BARBARA FAYE PRICE, is upwards of the age of twenty (20) years and will not attain the age of twenty-one (21) years until the month of November, 1954. That said minor, has, or will have, in the immediate future certain personal property in this County and State in connection with which it will necessary for her to exercise the right to contract and other incidents of the rights and responsibilities of a full adult person. Petitioner further shows that said minor is well educated for her years, is of a mature mind and manifests good judgment, is industrious and sober of habit, of good moral character and is fully capable of transacting her business affairs, and that it will be to the best interests of said minor to be relieved of the disabilities of non-age.

4. WHEREFORE, Your Petitioner respectfully prays that this

Honorable Court will set this Petition down for a day to be heard, and will direct the issuance of Notice to the said BARBARA FAYE PRICE of the filing of this Petition, and of the day set to hear and determine the same, in manner as provided by law; and that upon a hearing hereof it may please the Court to make and enter a decree unconditionally relieving the said BARBARA FAYE PRICE of the disabilities of non-age; and that this Honorable Court will make all such other orders and decrees in the premises as to it may seem just and proper.


My name is H. C. JORDAN, M.D., and I am a practicing physician on the Eastern Shore of Mobile Bay in Baldwin County, Alabama.


